

## 4. APPLICATION / LIMITATION

- 4.1 Tube fittings intended to be used on hydraulic systems on board ships and offshore units.
- 4.2 Application and installation of the tube fittings are to be in accordance with the manufacturer's specifications and instructions, and the Society's rules requirements.
- 4.3 The tube fittings are to be at any time accessible.
- 4.4 Tube fittings with tapered threads end connections are not to be used for liquid fuel or oil circuits in neither engine rooms nor any place containing an ignition source unless otherwise suitably screened at the Society's Surveyor satisfaction.
- 4.5 The nature of the used materials is to be suitable for the intended service.
- 4.6 For Bulkhead unions, the requirements given in BUREAU VERITAS Rules have to be complied with.
- 4.7 When soft seals are used for Bulkhead unions, it must be ensured that water, oil or fire cannot penetrate through the watertight bulkheads or decks.
- 4.8 Threaded type may not be used on watertight bulkheads.
