### 产品适用范围/Application of the Product

- 本认可的机械接头使用范围应符合中国船级社钢制海船入级规范2018版第三篇第二章第5节表2.5.3.1(2)和 2.5.3.1(3)的要求. These mechanical joints may be used in the system as specified in Table 2.5.3.1(2) and Table 2.5.3.1(3) of Section 5, Chapter 2, Part III of CCS RULES FOR CLASSIFICATION OF SEA-GOING STEEL SHIPS (2018).
- 2, 机械接头的材料应与所连接的管子以及内外部介质相适应. Material of mechanical joints is to be compatible with the piping material and internal and external media.
- 3,该认可的机械接头不应用于下列场合: Mechanical joints may not be used in the following cases:
  - (1) 穿过压载水舱或燃油舱的舱底水管系.Bilge piping through ballast tanks and fuel tanks;
- (2) 穿过货舱或燃油舱的海水管系和压载管系(包括空气管系和溢流管系). Sea water and ballast piping (including air and overflow pipes) through cargo holds and fuel tanks;
- (3) 穿过机器处所,货舱和压载舱的燃油和其他油类管路(含空气管路和溢流管路).Fuel and oil piping (including air and overflow pipes) through machinery spaces, cargo holds and ballast tanks;
- (4) 压力水雾系统中的非注水管(干管系统)Non-water filled pressure water spraying systems (dry pipe systems).

### 认可保持条件/ Maintenance Requirements of Approval

1. 型式认可后,如果产品及其重要零部件的设计、所用材料或制造方法有所改变,且影响到产品的主要特性、特征;或产品的性能指标有所更改,且超过认可的范围,则有关图纸和文件应经检验机构审批。并在检验机构认为必要时,经本社检验人员见证有关试验和进行检查,其结果应能证实仍符合认可条件。 After type approval, if there are changes to the design, materials used or manufacturing method of

product and important components and such changes affect major characteristics and properties of the product, or property indexes of the product are changed and exceed the scope of approval, related drawings and documents are to be examined and approved by the concerned survey office. Where deemed necessary by the survey office, the surveyor to the Society will go to witness relevant tests and conduct inspection and the results should be able to demonstrate compliance with the approval conditions.
